As good as it gets

Global real estate industry, investment managers record impressive growth

espite the continuing adverse effects of the coronavirus pandemic on societies and economies around the world, the institutional real estate asset class and industry continued to record impressive performance and growth in 2021. In fact, the global real estate industry grew by a phenomenal 22 percent year-over-year, according to the findings of *Global Investment Managers 2022*, the results of the annual survey sponsored by Property Funds Research and Institutional Real Estate, Inc. The survey received responses from 228 investment managers that represent total global real estate assets under management of €5.1 trillion (based on 2021 AUM figures), a substantial increase from last year's survey total of €4.1 trillion (based on 212 survey respondents).


Investors have flocked to the asset class, attracted by its stability and performance in the face of socioeconomic uncertainty and financial market volatility. In 2021, investment managers raised a record €137.8 billion for private equity closed-end funds that closed during the year, according to the IREI.Q database. In addition to the strong flow of new capital, some sectors and regions enjoyed healthy fundamentals and appreciation. In the United States, for example, the NCREIF Property Index posted a one-year total return of 17.7 percent, which included 13.0 percent from appreciation.

"2021 was certainly a strong year for institutional real estate as many economies around the world opened up after pandemic-related shutdowns," says Geoffrey Dohrmann, chairman and CEO of Institutional Real Estate, Inc. "We saw record capital formation and transaction activity last year, and investment managers have prospered from the asset class's recent performance. However, a number of challenges have emerged recently — rising interest rates, rampant inflation and the Russia-Ukraine conflict — all of which will have implications for investors and investment markets."

It's no surprise the industry's largest investment manager is Blackstone, which reported total real estate AUM of €419.9 billion, more than twice as much as the No. 2 ranked Brookfield Asset Management, which oversees AUM of €208.1 billion. Rounding out the top five were MetLife Investment Management (€175.7 billion), PGIM Real Estate (€144.3 billion) and Nuveen Real Estate (€133.9 billion).

In this year's survey, 12 firms reported AUM greater than \$100 billion; five years ago, there were only three — Blackstone, Brookfield and PGIM. Reflective of the industry's growth spurt, 13 of the top 20 firms recorded double-digit growth during 2021. The top 10 firms in this year's rankings control €1.6 trillion of AUM, an increase of 18 percent from last year's figure of €1.4 trillion and an increase of 76 percent from five years ago when the 2016 total was €92 billion. The top 10 investment managers account for 32 percent of the global AUM, and the top 20 firms account for nearly 50 percent of total AUM.

Top 100 firms in this year's rankings represent €4.6 trillion, a 20 percent jump from last year's total of €379.7 trillion and an increase of nearly 84 percent over five years (€2.5 trillion).

"The real estate market is currently challenged by several headwinds," says Jane Fear, managing director at Property Funds Research. "Despite this, the current consensus is that a global recession remains an unlikely event. However, this volatile and uncertain environment will likely result in some investors adopting a wait-and-see stance where opportunities are reassessed and risk repriced. On the other hand, as real estate has acquired the status it deserves as a main asset class, we do not expect allocations to suffer. On balance, we would expect the fund management industry to continue

to grow but at a lower rate than in the past. Some further manager consolidation could also happen as large and small-niche managers seem to do better than mid-size ones."

Blackstone ranks as the largest investment manager based on AUM just in North America. The firm manages €169.6 billion in the region. In Europe, the top-ranking manager is Swiss Life Asset Managers, with AUM of €111.8 billion, and in Asia, GLP claims the most assets with AUM of €70.8 billion. In the Australasia region, Charter Hall ranks No. 1 with AUM of €39.2 billion. PGIM Real Estate oversees the most assets in Latin America, with AUM of €3.06 billion. The report also ranks real estate managers based on their total AUM in the categories of discretionary separate accounts under management, advisory separate accounts and assets, and indirect real estate investment vehicles. PGIM Real Estate manages the most capital based solely on discretionary separate accounts, with AUM of €54.4 billion (see page 13). In the category of advisory separate accounts, MetLife Investment Management tops the list, with AUM of approximately €141.2 billion (see page 17). And based on indirect real estate investment vehicles, Blackstone ranks highest, with an asset base of €398.4 billion (see page 22). ❖
